

PRESS ACCREDITATION STANDARDS MM-AC EVENTS

Accreditation for the press wishing to cover Milagre Metaleiro Associação Cultural events is limited and will be awarded based on the following criteria:

- Journalists who represent local, regional, national or international media bodies, upon presentation of a professional card;
- Freelancers, with or without a professional license, upon presentation of a declaration from a Social Communication Body and/or upon presentation of an explanatory text of the objectives of the work to be carried out at MM-AC events;
- Bloggers and similar people whose work is considered relevant by MM-AC.

NOTE: The number of accredited journalists and photographers will be limited and requests will be evaluated by the festival organization

SUBMISSION OF THE ACCREDITATION REQUEST

Accreditation requests must be submitted between May 1st and June 15th using the form at https://milagremetaleiro.eu/press/, filling in all the fields.

The decision to grant or reject the claim will be communicated by July 15th.

If the request is made by a freelancer, a brief presentation must be sent describing the objectives of the work to be carried out in the "observations" field.

Any failure, false information or omission is grounds for rejection.

The approval or rejection will be communicated by email and the sender will be press@milagremetaleiro.eu.

Submitting the accreditation request implies full acceptance of the accreditation standards

expressed here.

PICKING UP YOUR ACCREDUTATION

Accreditations must be collected on the **first day** of the respective event, at the ticket counter for the press, upon presentation of an identification document.

RIGHTS OF ACCREDITATION HOLDERS

- Accredited holders will be able to move freely throughout the Festival's various public spaces, not including Backstage and other reserved areas;
- Accredited holders will only have access to Backstage after authorization from the organization and accompanied by a member of the organization;
- Accredited holders will always have support from the communications team;
- A Whatsapp group will be available for information and clarification of doubts;
- A space will also be made available for the press.

OBLIGATIONS OF ACCREDITATION HOLDERS

- Accreditation holders may not transmit the accreditation to another person or use it to introduce non-accredited people into the premises;
- The movement of accreditation holders in reserved areas (including backstage, except when previously authorized) is expressly prohibited.

STANDARDS FOR IMAGE CAPTURE

- Accredited holders must provide the captured material free of charge, either to the organization or to the artists, if requested.
- Accredited holders must respect any limitations to photographic coverage imposed by the organization's needs or the artists' demands.
- Accredited holders may not make audio or video recordings without prior authorization from the organization/artists.
- In the photo pit, the photographer can only photograph the first 3 songs without flash.

Whenever you are asked to leave, you must do so immediately.
